The Association of Washington Business (AWB) has compiled this roll call of the legislative votes so you will know how members of the Washington State Legislature voted on important issues in the 1995 Legislative Session.

The Voting Record

Voting records cannot tell the entire story of a legislator's attitude, or whether the final vote on an issue accurately represents that legislator's position throughout the debate. However, the AWB Voting Record is designed to be a representative sample of votes on the over 2,500 bills introduced during the Session. This year's selection includes 22 key Senate votes and 23 key House votes, chosen from the more than 1,000 floor votes cast by legislators.

How The Issues Were Chosen

The issues included in this voting record were selected by AWB members in a thorough and extensive process. First,

an 18-member Voting Record Task Force reviewed the vote criteria and developed an initial list of issues to be included. The proposed list and suggested format were then reviewed and approved by the Association's Governmental Affairs Council, with approximately 65 members participating. The final report was then reviewed by AWB's Executive Committee prior to publication.

The 1995 Legislative Session

Overall, the 1995 Legislative Session was a good one for AWB members. The Legislature passed health, regulatory and land use reform, reduced Business & Occupation taxes, cut Unemployment Insurance taxes and exempted new manufacturing machinery and equipment from the sales tax.

ENVIRONMENT

SHB 1220

Air Operating Permit Exemption

The House approved 98-0 and the Senate approved 48-0 legislation that would exempt air operating permits from SEPA review. This bill was supported by both AWB and the Department of Ecology. SHB 1220 was signed into law (Ch. 172 L 95). A "Y" vote reflects the AWB position.

ESHB 1274

Growth Management Revisions

The House approved 62-33 this omnibus bill that would amend the Growth Management Act (GMA). The bill provides additional flexibility in population projections for the Office of Financial Management; more clearly define how an area is designated to be an Urban Growth Area (UGA); and permit counties discretion in siting industrial and large commercial business parks outside of Urban Growth Areas. ESHB 1274 died in the Senate Government Operations Committee. A "Y" vote reflects the AWB position.

EHB 1305

Growth Management Revisions

The Senate amended and approved 35-13, the House concurred 85-10. This growth management bill defines Urban Growth Areas (UGA) and clarifies what is appropriate development in rural areas. A "Y" vote is consistent with the AWB position.

ESHB 1724

SEPA/GMA Integration

The Senate amended this bill and approved 44-0, the House concurred 94-0. ESHB 1724 incorporates the Governor's Task Force on Regulatory Reform recommendations on integrating the State Environmental Protection Act (SEPA) with the Growth Management Act (GMA) and the Shorelines Management Act (SMA). ESHB 1724 has been signed into law (Ch. 347 L 95). A "Y" vote reflects the AWB position on the need to clarify and streamline land use laws.

ESHB 1791

Water Resources

The House approved 77-19 legislation that would remove the responsibility for water resources management from the Department of Eco-

However, AWB was disappointed in the Governor's veto of the Business and Occupation tax reduction and the partial veto of the Regulatory Reform bill.

In addition, many of AWB's most important workers' compensation bills died in the Senate Labor and Commerce Committee, and the entire roster of AWB's water resource measures died in the Senate Select Committee on Water Policy. Votes on all of these major issues are included in the AWB Voting Record.

AWB believes the votes included in this Voting Record are a fair representation of a legislator's tendency to support or oppose AWB members on business issues. We urge a careful review of your legislator on a vote by vote basis, as well as by a composite percentage.

ogy and create two state commissions (east and west side) to manage water resources for the state. AWB supported this legislation that died in the Senate Select Committee on Water Policy.

ESHB 1810

Model Toxics

The House approved 86-11 and the Senate approved 47-0 legislation that would create a legislative study commission for the review of MTCA clean up standards and procedures. ESHB 1810 also calls for a pilot project to investigate the application of more flexible clean up procedures for the purpose of increased efficiency and effectiveness in clean up efforts. A "Y" vote is consistent with the AWB position.

ESSB 5194

Puget Sound Water Quality Authority

The Senate approved 33-16 legislation that would establish the Puget Sound Water Quality Authority (PSWQA) as a permanent agency. ESSB 5194 died in the House Agriculture and Ecology Committee without coming up for a vote. A "N" vote is consistent with the AWB position that the Puget Sound Water Quality Authority has completed its mission and should sunset as scheduled.

HEALTH CARE**HB 1029****Delay of Uniform****Benefits Package Implementation**

The House approved 66-28 legislation that would delay the implementation of the Uniform Benefits Package (UBP) by a year and would require legislative action before implementation of a benefits package. This bill needed action in the first 30 days of session. This vote was indicative of the desire to revisit the 1993 Health Services Act. HB 1029 died in the Senate Health & Long Term Care Committee without coming up for a vote. A "Y" vote is consistent with the AWB position.

ESHB 1046 - Final Passage**Revising the 1993 Health Services Act**

ESHB 1046 was amended in the Senate and approved 39-9, the House concurred 77-19 on this important health care bill. ESHB 1046 removes the employer and individual mandates that were put in place in 1993. The bill also expands access to the state's Basic Health Plan; retains insurance reforms, such as portability; allows for Medical Savings Accounts; replaces the Health Services Commission with a nine member advisory board. ESHB 1046 has been signed into law (Ch. 265 L 95) as part of a three piece package. AWB strongly supports this legislation.

SHB 1046**Revising the 1993 Health Services Act**

SHB 1046 was approved by the House 71-27. SHB 1046 removes the employer and individual mandates that were put in place in 1993. The bill also expands access to the state's Basic Health Plan; retains insurance reforms, such as portability; allows for Medical Savings Accounts; and repeals the Health Services Commission. SHB 1046 also contained a referendum to the people. SHB 1046 died in the Senate Health and Long Term Care Committee but was ultimately passed by the conference committee as ESHB 1046 as part of a three piece health care package. A "Y" vote is consistent with the AWB position.

The final health care votes represented an agreement with the House, Senate, and Governor. The agreement included that there be no changes to the final bill on the senate floor. Although there were a number of votes that were taken on amendments, only the following six amendments were recorded roll call votes. The remainder of amendments were not adopted and were taken by voice vote, withdrawn, or declared out of scope and object.

ESHB 1046 (A-1)**Health Care-Heavey & Franklin Amendment**

This amendment offered by Senator Heavey and Senator Franklin would have added chiropractic benefits to the Basic Health Plan (BHP). This amendment was not part of the agreement and failed 21-26. A "N" vote is consistent with the AWB position.

ESHB 1046 (A-2)**Health Care-Fairley Amendment**

This amendment offered by Senator Fairley would have added chiropractic care, midwifery, mental health, substance abuse, organ transplant and medical rehabilitation to the BHP. This amendment was not part of the agreement and failed 21-27. A "N" vote is consistent with the AWB position.

ESHB 1046 (A-3)**Health Care-Quigley Amendment**

Senator Quigley offered an amendment that would have limited the individual rate to not more than 110% of the group rate. This amendment was not part of the agreement and failed 19-29. A "N" vote is consistent with the AWB position.

ESHB 1046 (A-4)**Health Care-Quigley Amendment**

Senator Quigley offered an additional amendment that would require all providers to include any willing provider. This amendment was not part of the agreement and failed 23-25. A "N" vote reflects the AWB position.

ESHB 1046 (A-5)**Health Care-Hargrove & Rasmussen Amendment**

This amendment offered by Senator Hargrove and Senator Rasmussen would have eliminated the Health Services Commission. This amendment was not part of the agreement and failed 19-29. A "N" vote reflects the AWB position.

ESHB 1046 (A-6)**Health Care-Kohl & Franklin Amendment**

This amendment offered by Senator Kohl and Senator Franklin would require written disclosure of coverage and benefits. This amendment was not part of the agreement and failed 20-28. A "N" vote is consistent with the AWB position.

HUMAN RESOURCES**ESHB 1451****Group Self Insurance Expansion**

The House approved this bill 63-32. ESHB 1451 would expand the workers' compensation program to allow group self-insurance. Currently only selected hospitals and school districts may group self-insure workers' compensation. ESHB 1451 died in the Senate Labor, Commerce and Trade Committee without coming up for a vote. A "Y" vote reflects the AWB position.

SHB 1451 (A-1)**Group Self Insurance Expansion Amendment**

The House defeated 42-53 this amendment to the workers' compensation bill which would have expanded group self-insurance. If group self-insurance had passed this amendment would have created an ambiguous administrative sanction and private right of action against group self-insurance employers which would have undermined the exclusive remedy foundation of the workers' compensation system. A "N" vote reflects the AWB position.

SHB 1910**Workers' Compensation Self Insurer**

The House approved 68-28 this workers' compensation bill that would allow self-insured employers to close disability claims. SHB 1910 died in the Senate Labor, Commerce and Trade Committee without coming up for a vote. A "Y" vote is consistent with the AWB position.

SHB 1911**Workers' Compensation - Retro**

The House Approved 89-7 a workers' compensation bill that would allow State Fund Retro employers to be more involved in returning their injured workers to the job. HB 1911 died in the Senate Rules Committee without coming up for a vote. A "Y" vote is consistent with the AWB position.

SB 5614**Workers' Compensation - Industrial Insurance Appeals**

The Senate approved 30-19 a workers' compensation bill which would discourage employers from challenging many fraudulent claims. SB 5614 would require payment of benefits to claimants during all employer appeals instead of the current practice of evaluating the merits of the appeal. SB 5614 died in the House Labor and Commerce Committee. A "N" vote reflects the AWB position.

ESB 5925**Modifying the Determination of Unemployment Insurance Contribution Rates**

The Senate approved 44-5 and the House approved 68-29 this important unemployment insurance bill. ESB 5925 permanently rolls back two unnecessary unemployment insurance tax increases and adjusts the tax trigger schedule. ESB 5925 has been signed into law (Ch. 4 L 95). A "Y" vote is consistent with the AWB position.

REGULATORY REFORM

ESHB 1010

Regulatory Reform - Final Passage as Amended by the Senate

The House passed HB 1010 early in the session, it was amended in the Senate and approved 38-10, the House concurred 89-8. ESHB 1010 restricts agency rulemaking authority; requires agencies to use strict criteria to ensure that all new regulations are as cost-efficient and effective as possible; requires agencies to prove need before exceeding federal standards; allows you to collect attorneys fees and costs if you successfully sue the state over a bad regulation; and encourages agencies to stress education before enforcement. ESHB 1010 has been signed into law (Ch. 403 L 95). A "Y" vote reflects the AWB position.

ESHB 1010-A1

Regulatory Reform - Hale Amendment (OIC)

The Senate approved 25-24 this regulatory reform amendment that adds the Office of the Insurance Commissioner (OIC) to the grants of authority section of ESHB 1010. The President of the Senate cast the tie breaking vote on this important amendment. The Governor vetoed this provision from the bill before signing into law. A "Y" vote is consistent with AWB's position.

ESHB 1010-A2

Regulatory Reform - Hale Amendment (DLI)

By a vote of 25-24 the Senate approved this amendment that adds the Department of Labor and Industries (DLI) to the grants of authority section of ESHB 1010. The President of the Senate cast the tie breaking vote on this controversial amendment. The Governor vetoed this provision from the bill before signing into law. A "Y" vote reflects the AWB position.

ESHB 1010-A3

Regulatory Reform - Hale Amendment

The Senate approved 25-24 an amendment that requires the Department of Ecology (DOE) to justify exceeding the federal clean air act in adopting or amending rules. The President of the Senate cast the tie breaking vote on this amendment. A "Y" vote is consistent with the AWB position.

ESHB 1010-V1

Regulatory Reform - Veto Override (OIC)

The House approved 64-29 a motion to override the governor's veto decision to remove the Office of the Insurance Commissioner (OIC) from the grants of authority section of ESHB 1010. A two thirds majority in both houses is needed for a veto override. A "Y" vote is consistent with the AWB position to include the OIC in the grants of authority section of ESHB 1010.

ESHB 1010-V2

Regulatory Reform - Veto Override (DLI)

The House approved 62-30 a motion to override the governor's veto decision to remove the Department of Labor and Industries (DLI) from the grants of authority section of ESHB 1010. RCW 39.12 (prevailing wage) would be exempt from this section due to pending court cases. A two thirds majority in both houses is needed for a veto override. A "Y" vote is consistent with the AWB position to include all state agencies in the grants of authority section of ESHB 1010.

ESHB 1010-V3

Regulatory Reform - Veto Override (FPPB)

The House approved 68-25 a motion to override the governor's veto decision to remove the Forest Practices Board from the grants of authority section of ESHB 1010. A two thirds majority in both houses is needed for a veto override. A "Y" vote is consistent with the AWB position.

ESHB 1010-V4

Regulatory Reform - Veto Override (JARRC)

The House approved 69-24 a motion to override the governor's decision to veto section 504 from ESHB 1010. This section would allow findings made by JARRC (Joint Administrative Rules Review Committee) to be used as a rebuttable presumption in the court of law. A "Y" vote reflects the AWB position in strengthening JARRC.

ESHB 1010-VC

Senate Partial Veto Message Consideration

The Senate rejected 22-25 a motion to consider sections vetoed by the Governor for possible override on the substantive issues. A "Y" vote is consistent with the AWB position.

TAX & FISCAL POLICY

EHB 1023

B&O Tax Reduction

The House approved 97-1 and the Senate approved 41-6, legislation that reduces the B&O tax increases from 1993 on the service sector by half. A "Y" vote is consistent with AWB's position.

E2SHB 1024

Manufacturer's Sales & Use Tax Exemption

The House approved 91-6 a bill that would exempt equipment and machinery purchased and used by manufacturers and research and development firms from the sales and use tax, as well as the labor to install it. This bill died in the Senate Ways and Means Committee without coming up for a vote, the language was later used by the conference committee in ESSB 5201. A "Y" vote reflects the position of AWB that this repeal would increase economic expansion in the state of Washington.

HB 2072

B&O Tax Increase Repeal

The House approved 92-6 additional tax relief legislation that eliminates the B&O tax increases from 1993 on the service sector. The full removal to the service sector was available by additional funding in the House budget. This bill died in the Senate Ways and Means Committee without coming up for a vote. A "Y" vote is consistent with AWB's position.

SSB 5000

Property Tax

The Senate approved 25-22, a bill that would have amended Initiative 601 to divert revenues from the emergency reserve fund to create a special account used to reduce state property taxes. The vote did not achieve the constitutionally required two thirds majority necessary for passage. A "Y" vote reflects the AWB position of preserving the integrity of Initiative 601.

ESSB 5201

Manufacturer's Sales & Use Tax Exemption

The Senate approved 45-4 and the House approved 92-5, a bill that would exempt manufacturing equipment and machinery from the sales and use tax, as well as the labor to install it. The Governor signed this bill into law (Ch. 3 L 95). A "Y" vote reflects the position of AWB that this repeal would increase economic expansion in the state of Washington.
